



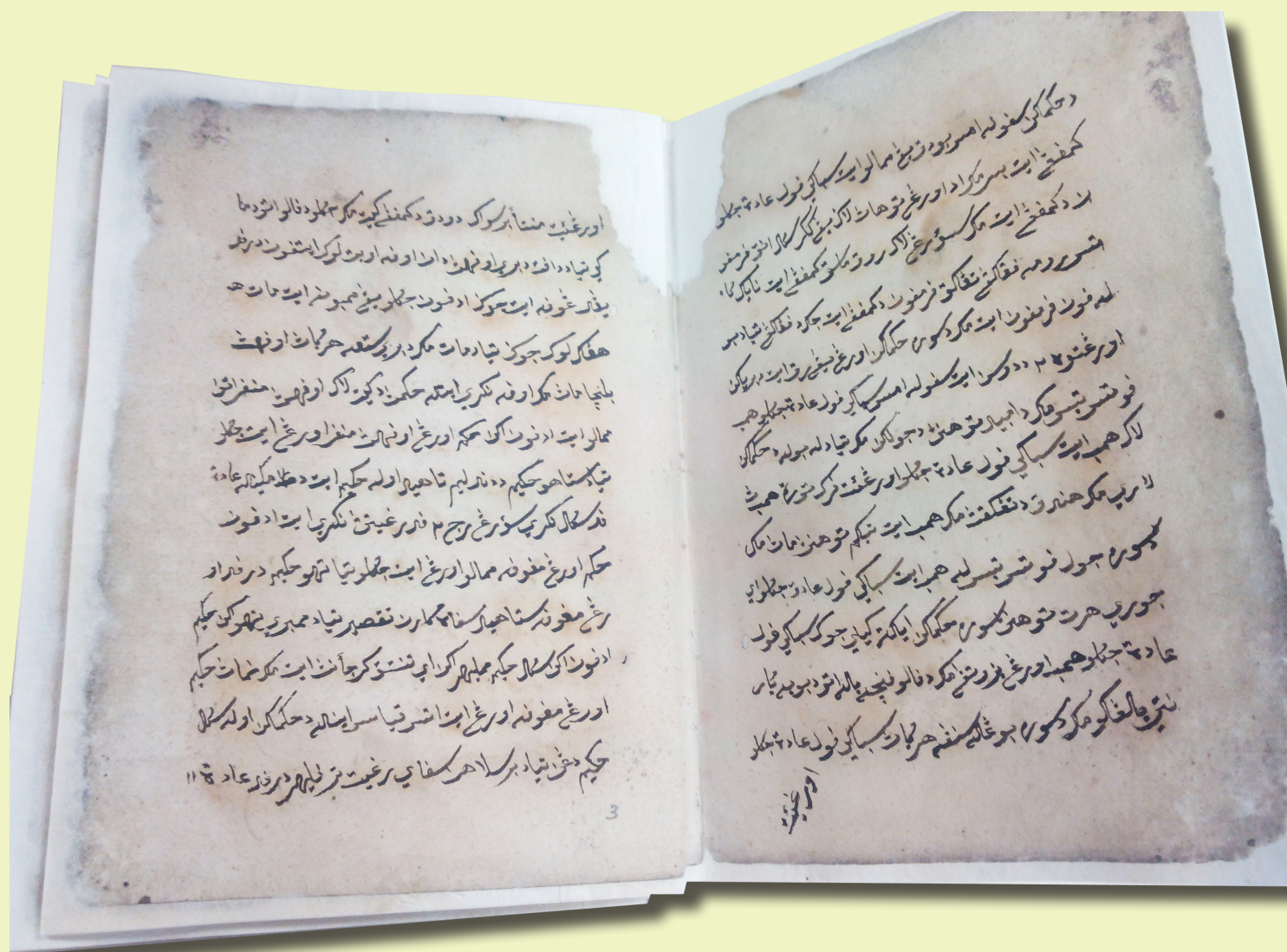

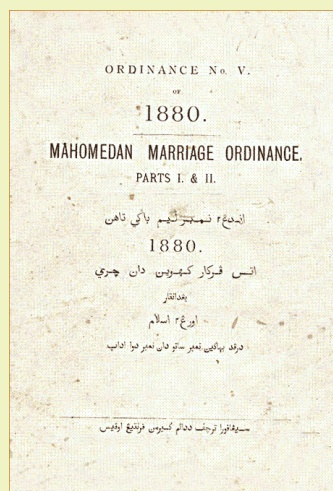

ORDINANCE 1908.

ORDINANCE NO. XXV OF 1908.

AN Ordinance to consolidate and amend the Law for the Registration of Marriages and Divorces among Muhammadans and to provide for the Appointment of Kathis.

[20th November, 1908.]

It is hereby enacted by the Governor of the Straits Settlements with the advice and consent of the Legislative Council thereof as follows:—

1. This Ordinance may be cited as "The Muhammadan Marriage Ordinance 1908," and shall come into operation on a day to be fixed by the Governor in Council by notification in the *Gazette*.*

2. The Ordinances set forth in the Schedule hereto are severally repealed to the extent mentioned in the third column of the said Schedule.

3. In this Ordinance "revocation of divorce" means the Definition, revocation of divorce known in Mohammedan law as *ra'id*.

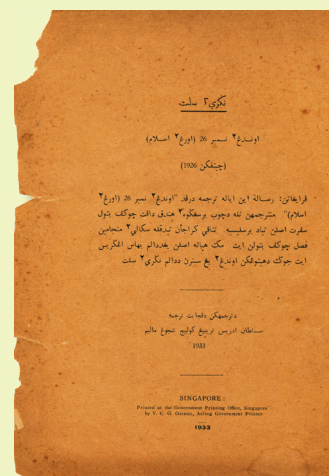
4. The Governor may, appoint at each Settlement, either by name or office, a person to have the title of "Registrar of Muhammadan Marriages" and in this Ordinance the word Registrar shall mean a person so appointed. The appointment of a Registrar shall be notified in the *Gazette*. The Governor may at any time at his pleasure by a notification in the *Gazette* cancel such appointment.

5.—(1) The Governor may appoint any male Muhammadan of good character and position and of suitable attainments to be a Kathi. The letter of appointment shall be in such form as the Governor may specify by a Rule under this Ordinance, shall be signed by the Colonial Secretary, and shall either state that the person named therein is appointed to be a Kathi for a particular district or place, of which the limits shall be strictly defined, or shall state that the person named therein is appointed to be a Kathi for particular nationalities or sects.

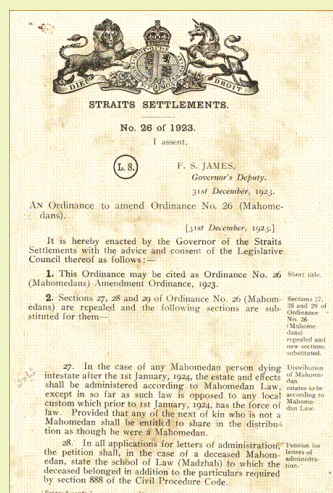

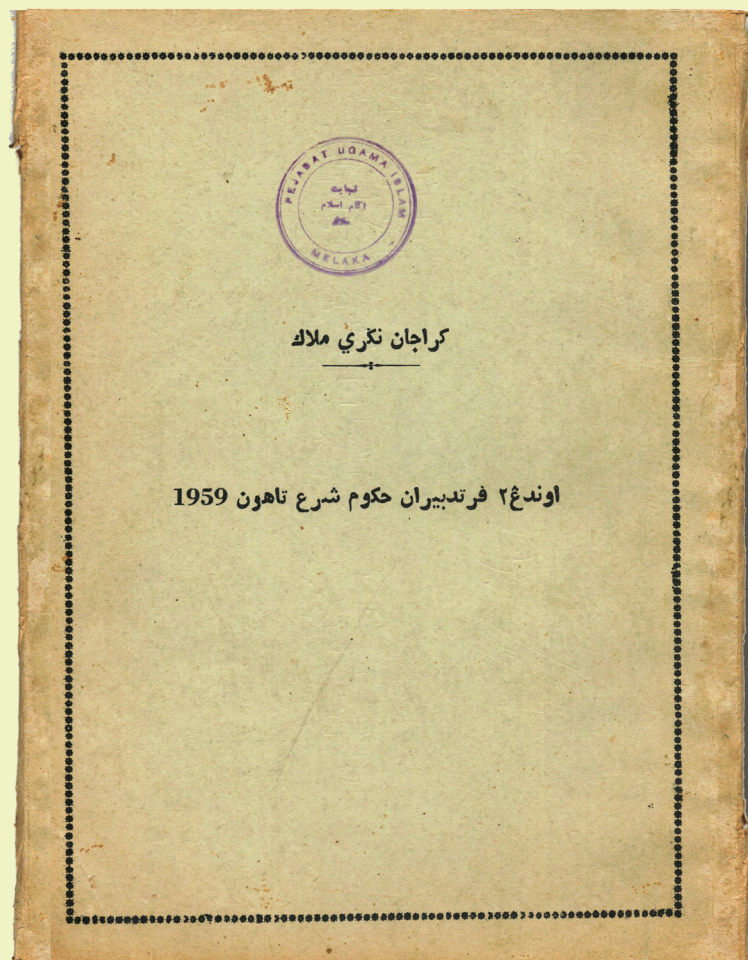

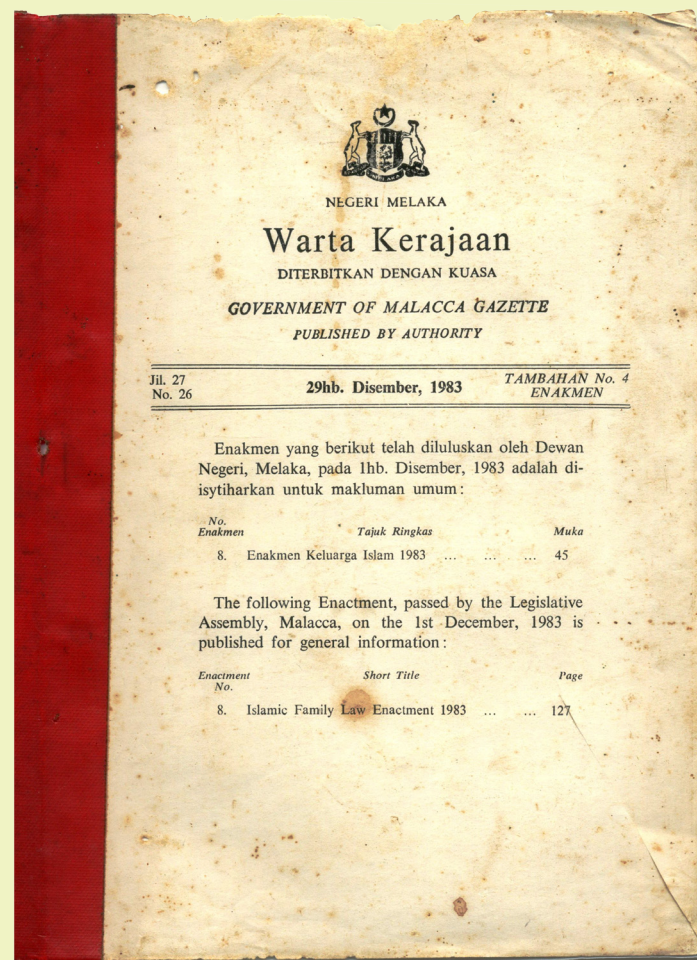
Ordinance No 26 (Mahomedans) 1923
